



## Terms & Conditions – TSA festive greeting card design 2021 competition

8. The entrant grant the TSA an irrevocable, perpetual, non-exclusive right to use the images submitted for the competition for the TSA's promotional and charitable activities. Entrants agree their image (if a winner) will be used by the TSA for its cards available for the public and supporters to purchase from their online shop and other activities. The proceeds from the sale of the Festive cards will go towards the charitable activities of the TSA and no royalties will be payable to the winning entrant.
9. By taking part in this competition, you understand that the images may be used by the TSA for general marketing purposes and may appear in magazines, local, regional and national communications, both in print and online.
