## AMENDING YOUR WILL

If you already have a Will and would like to add a cash and/or specific gift for the Tuberos Sclerosis Association, you can do so by completing this simple Codicil form.

Please **do not** write on your existing Will as it could become invalid.

## CODICIL FORM GUIDANCE NOTES

We hope you find these guidance notes useful. Please note that this guidance does not constitute legal advice. If you have any questions, we recommend that you ask a solicitor or legal professional for advice.

### 1. Ask two people to witness your signature.

Please ensure you sign this form in the presence of two independent witnesses.

The following people cannot witness your Codicil:

- An executor or trustee of your Will
- An executor's or trustee's spouse or civil partner
- A beneficiary of your Will or Codicil
- A beneficiary's spouse or civil partner

### 2. Sign the Codicil in the presence of both your witnesses.

**3. Ask your witnesses to complete their sections in the presence of you and each other.** It is also advisable for you and your witnesses to sign at the foot of each page.

**4. Take a photocopy of your Codicil** and send the original to your solicitor, or whoever is safeguarding your Will.

**5. You can add more than one Codicil to an existing Will.** Please indicate the version number when completing the form, for example 'first Codicil' or 'third Codicil'.

If you wish to leave the TSA part or all your residuary estate (i.e. a share or whole) we advise that you replace an existing Will and consult a solicitor or legal professional. You can find one in your local area by contacting the Law Society in:
